Dr. Karen Fortuna, Assistant Professor of Psychiatry at Dartmouth College, has a PhD in Social Welfare and is a Licensed Independent Clinical Social Worker. Dr. Fortuna works in partnership with vulnerable populations, including adults with a diagnosis of a serious mental illness, in the United States, Canada, Europe, Australia, Africa, and New Zealand in co-producing and empirically testing digital peer support technologies and trainings. Dr. Fortuna served as an international expert on the International Standards Advisory Committee to develop the first-ever accreditation standards for behavioral health care for older adults with CARF International.

Rob Walker is the President of the World Digital Peer Support Association and has worked in various peer roles in Massachusetts for over 15 years, recently managing the contract for Peer Specialist Training and certification in Massachusetts. Rob is an older adult with lived experience and uses his lived experience to create programs that involve peer specialists, and to extend the reach of peers into programs with Older Adults and people who are involved with the criminal justice system, as well as individuals who are unhoused.





Mary Jo McMillen has been in long-term recovery from substance use since September 16, 1985. She has worked with people who have Substance Use and Mental Health Disorders as a licensed Counselor since 1988. Since 2010, Mary Jo has been the Executive Director of Utah Support Advocates for Recovery Awareness (USARA), a non-profit peer-run Recovery Community Organization serving individuals and family members throughout Utah. USARA's mission is to connect and inspire communities to advocate for addiction recovery.

Charles H.
